ONLINE COUNSELLING FOR ADMISSION INTO D.PHARM AND B.PHARM COURSES IN THE INSTITUTES OF ASSAM AFFILIATED TO SSUHS FOR THE SESSION 2023 INCLUDING INSTITUTES RUN UNDER PRIVATE SECTOR

This is for information for all the aspirants who appeared the Common Entrance Examination, 2023 conducted by Srimanta Sankaradeva University of Health Sciences (SSUHS) for admission into D.Pharm and B.Pharm Courses in the institutes affiliated to SSUHS run under both Government and Private Sector that selection of eligible candidates (as per vide Notification No. SSUHS/316/2023/Ex/6753 dated 12-07-2023) for admission into State Quota seats of Govt. Pharmacy Colleges of Assam and 50% seats of Private Pharmacy Colleges under SSUHS will be done through Common Online Counselling. The online filling of preferences for 1st round of conselling will be held from 30-08-2023 to 05-09-2023. A list of provisionally selected candidates will be displayed in the websites of Directorate of Medical Education, Assam & SSUHS on 08-09-2023.

The candidates are eligible for admission as per the following criteria:

The minimum cut off score in Common Entrance Examination as shown below:

- The eligibility criteria for admission into D.Pharm and B.Pharm Courses are as follows:
 - 1. Applicant must be a citizen of India.
 - Candidate must have passed Higher Secondary (10+2) Science or Equivalent Examination with English, Physics,
 Chemistry and Biology and/or Mathematics from recognized Board/Council/University without grace marks.
 However, the student's possing 10+2 qualification from non formal and non class rooms based schooling such
 as National Institute of Open Schooling, open school system of States etc. shall not be eligible for admission to
 B.Pharm Course.
 - 3. Candidate must be a minimum of 17 years on 31st December of the year in which admission is sought.

The students taking admission in Private Colleges shall be required to pay course fee etc. as per norms of the respective colleges.

Reservation of seat: There shall be reservation of seats for SC/ST(P)/ST(H)/OBC/MOBC/TGL/Ex-TGL/EWS/PwD
(Divyang) category from the available seats in the Govt. Pharmacy Colleges/ Institute as per Govt norms.
